

About PACE

The Program of All-inclusive Care for the Elderly (PACE) model is centered on the belief that it is better for the well-being of seniors with chronic care needs and their families to be served in the community whenever possible. PACE serves individuals aged 55 or older, certified by the state to need nursing home level of care, able to live safely in their community at the time of enrollment, and live in a PACE service area. Only about seven percent of PACE enrollees nationally reside in a nursing home and, if they do need nursing home care, the PACE program pays for it and continues to coordinate the enrollee's care.

Total Enrollees Served

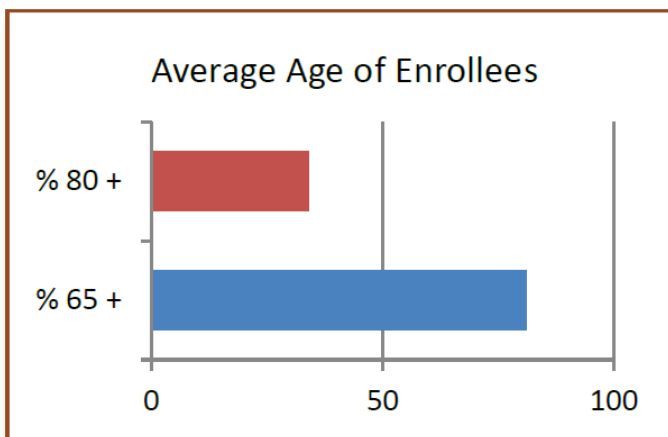
Since 2005, the operational PACE programs in California have served more than 27,000 enrollees. As of January 1, 2022, total enrollment statewide is more than 15,000 participants.

Enrollee Characteristics

The data below is reported as of July 1, 2021.

Age & Residency:

The average enrollee age is 75. In California, 98% of PACE enrollees reside in the community, with only 2% living in nursing homes. Over 77% of participants are 65 or older and 27% are 80 or older.

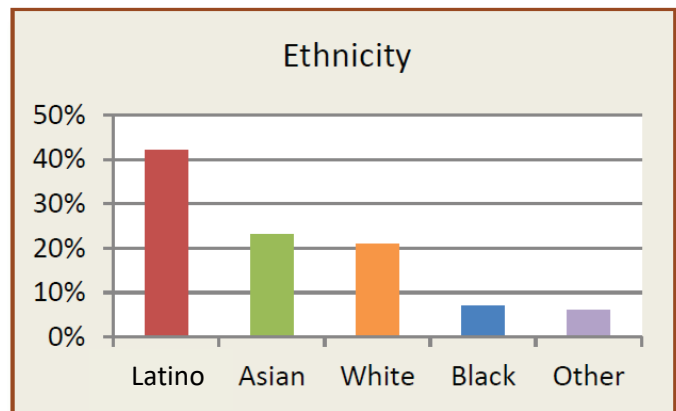


Eligibility for Medi-Cal & Medicare:

100% of enrollees are eligible for Medi-Cal. Currently 72% of enrollees are dually eligible for Medi-Cal and Medicare, and 28% are Medi-Cal eligible only.

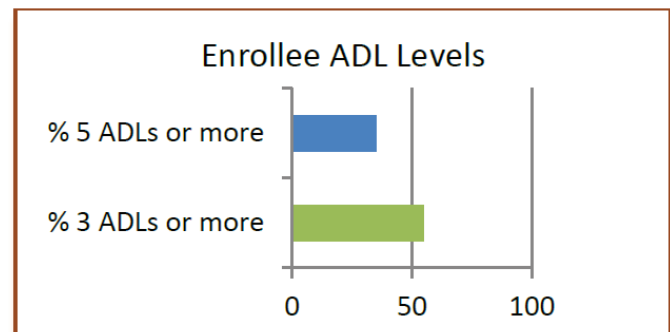
Multicultural & Multilingual:

Primary languages spoken are Spanish (40%), English (37%), and Chinese (10%).



Functional Status:

The average Activities of Daily Living (ADL)* level of PACE enrollees is 3.5.



*Routine activities include eating, bathing, getting dressed, toileting, and mobility.

CalPACE Program Characteristics

The California PACE Association (CalPACE) is a 501 (c) (6) association dedicated to the expansion of comprehensive health care services to the frail elderly through the Program of All-inclusive Care for the Elderly (PACE). CalPACE was officially incorporated in August 2007 and is one of the first statewide PACE Associations established in the United States.

As of 2022, our membership includes 23 operational PACE programs: AltaMed PACE, Bakersfield PACE, Brandman Centers for Senior Care (Los Angeles Jewish Home), CalOptima PACE, Center for Elders' Independence, Central Valley PACE, Family Health Centers of San Diego, Fresno PACE, Gary and Mary West PACE, InnovAge San Bernardino PACE, InnovAge Sacramento PACE, Neighborhood Healthcare PACE, NEMS PACE, On Lok PACE, Orange County PACE, Redwood Coast PACE, San Diego PACE, St. Paul's PACE, Sutter SeniorCare PACE, WelbeHealth Coastline PACE, WelbeHealth Pacific PACE, WelbeHealth Sequoia PACE, and WellbeHealth Sierra PACE. CalPACE members provide services through 69 PACE centers and alternative care sites in 22 counties—Alameda, Contra Costa, El Dorado, Fresno, Humboldt, Kern, Kings, Los Angeles, Madera, Orange, Placer, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, Santa Clara, San Joaquin, Stanislaus, Sutter, Tulare, and Yuba.
